3. FOR P/N 508792-401**, 510385-401**, 508794-401** AND 508793-401**, 508795-401** DO NOT PACK MORE THAN HALF OF THE ALLOWABLE POSITIONS FOR INFLATORS PER BOX (EXAMPLES: 24 POSITIONS=>12 INFLATORS, 12=>6, 6=>3).
4. FINAL BOX WEIGHT IS NOT TO EXCEED STAMPED RATING. REGARDLESS, NOT TO EXCEED 40 LBS.
5. IF PACKING FEWER INFLATORS THAN THE BOX CAN HOLD, DISTRIBUTE INFLATORS EVENLY THROUGHOUT BOX FOR WEIGHT DISTRIBUTION.

 - c. REMOVE ALL RESTRAINT HOSES FROM ALL INFLATORS BEING SHIPPED ALONG WITH "6a" AND/OR "6b" ABOVE.
 - d. REMOVE ALL CABLES FROM ALL INFLATORS.

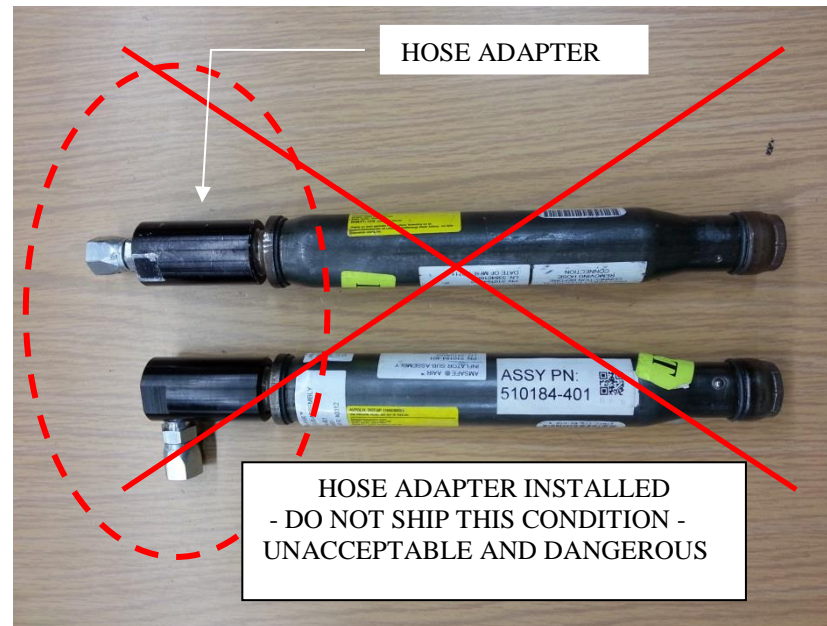

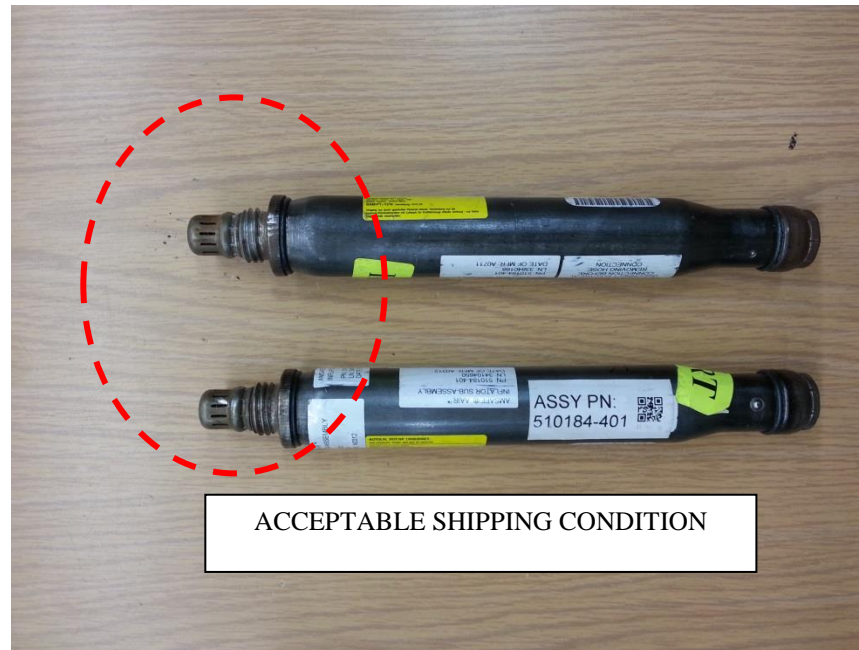

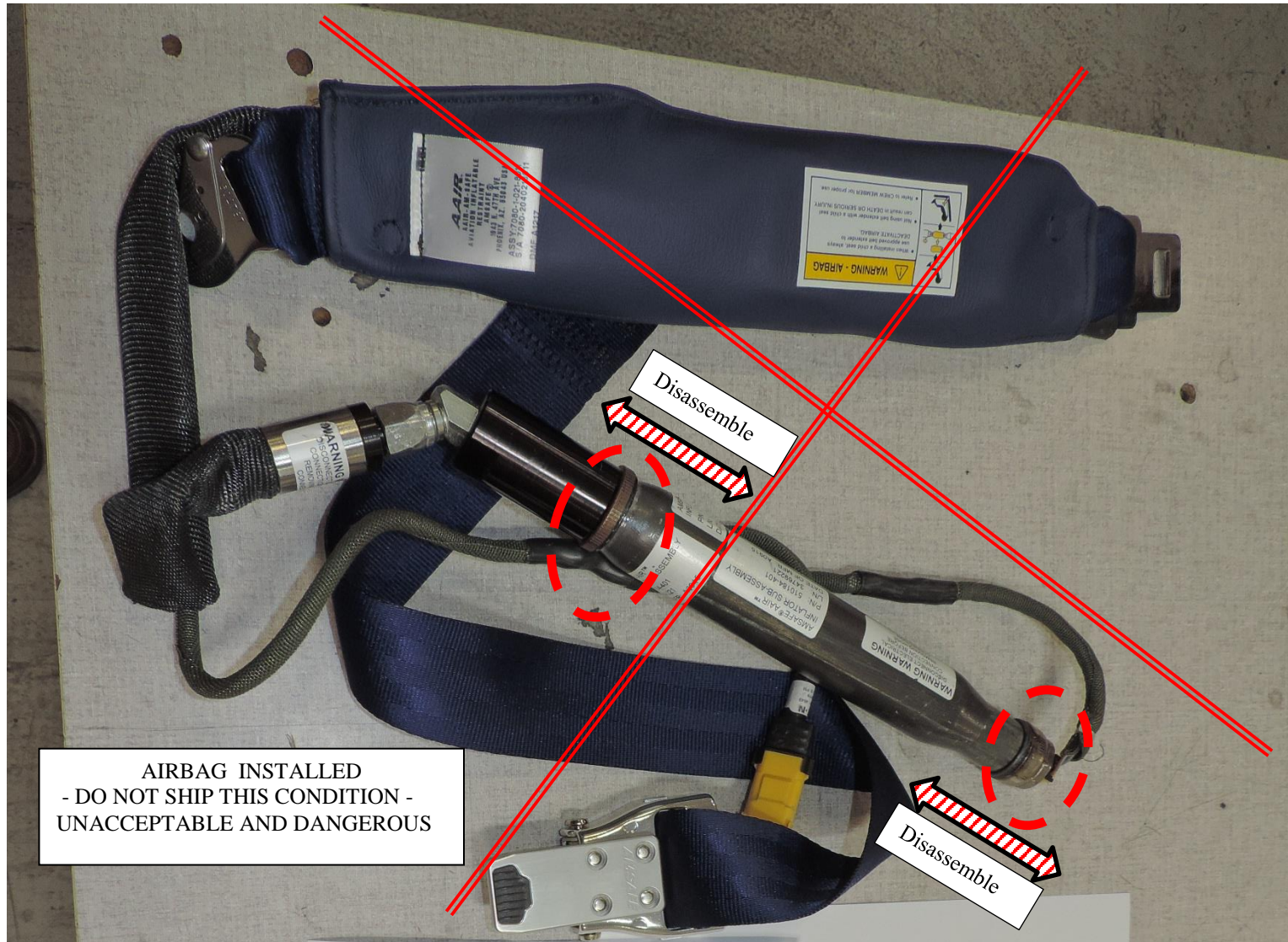

- c) Ensure all Hoses, Hose Fittings and electrical connections are removed from each inflator being shipped .

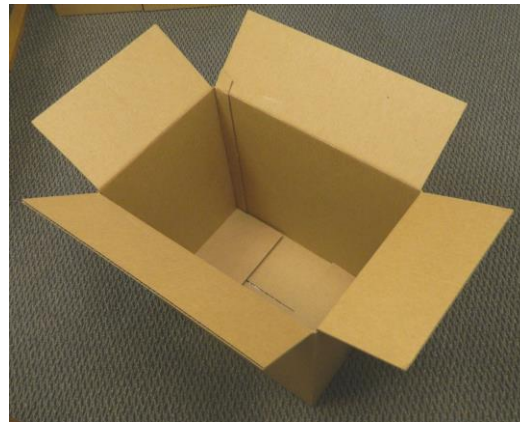


2. ASSEMBLE BOX AND TAPE THE BOTTOM CLOSED.

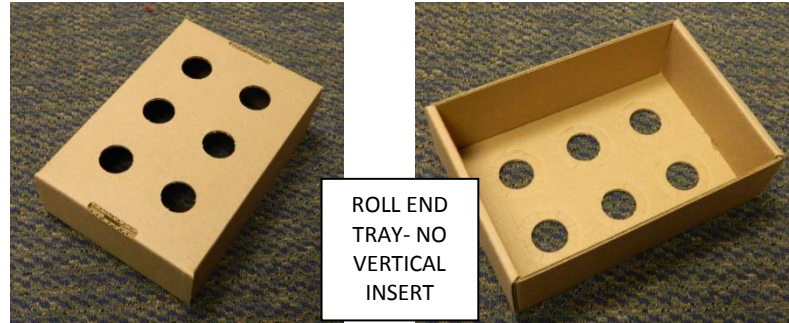

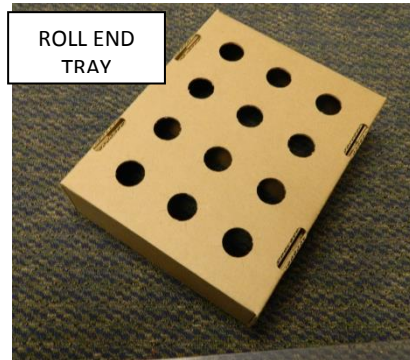

FOR THE 12 CELL BOX USE 514018-2, -4:

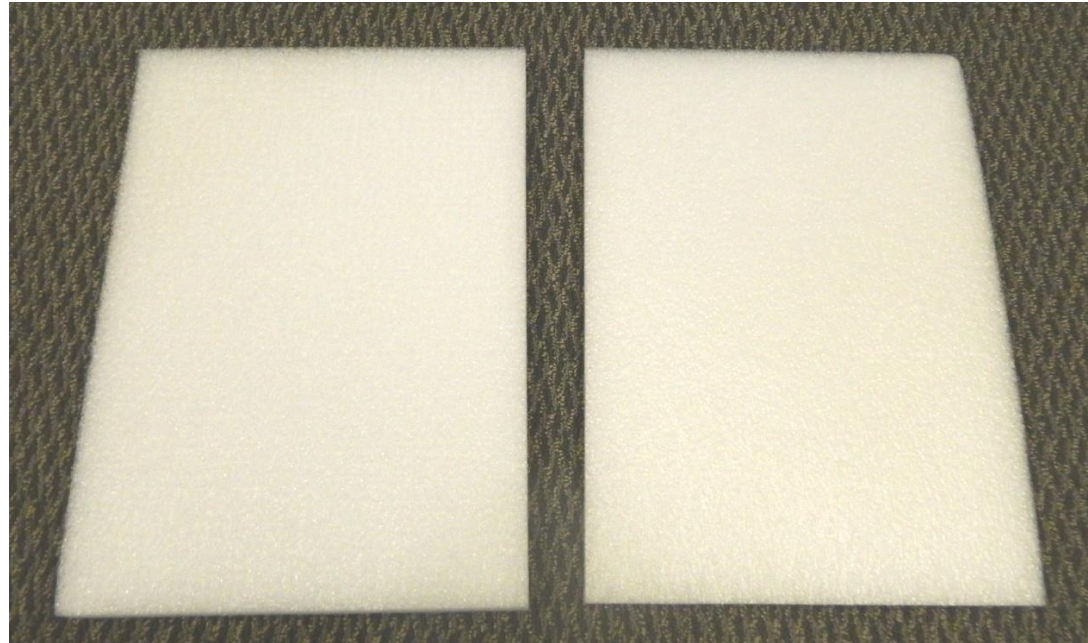

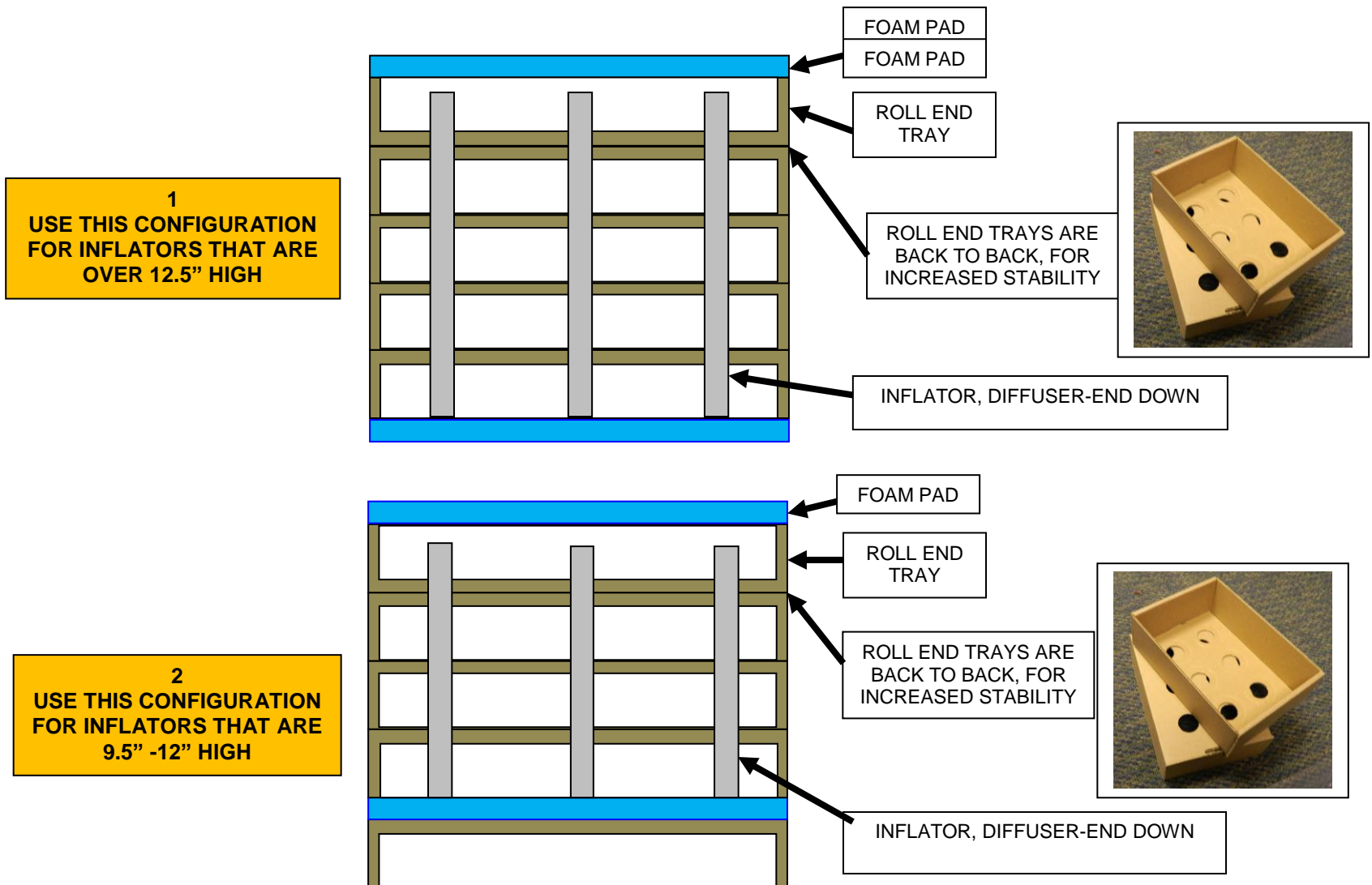

- FOR THE 24 CELL BOX QTY (2) USE 510277-3:

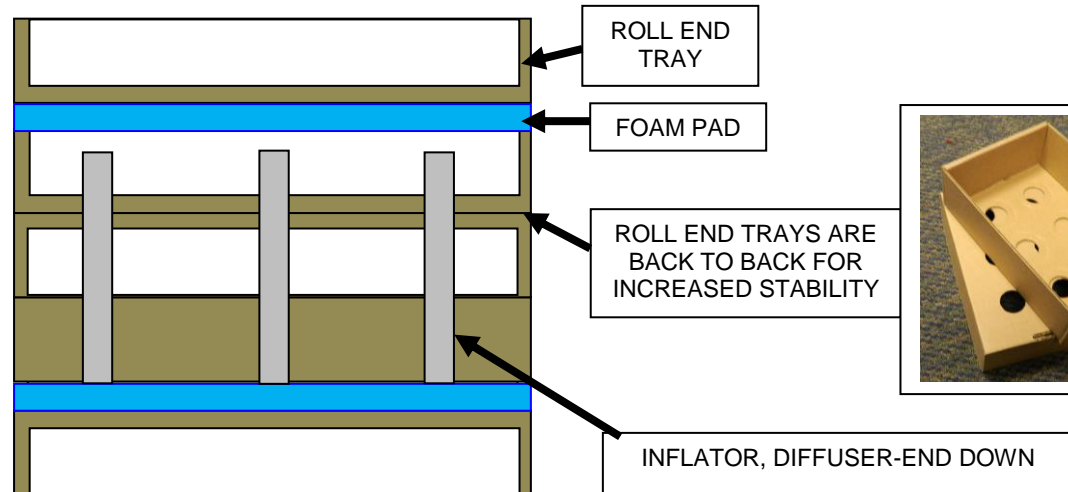

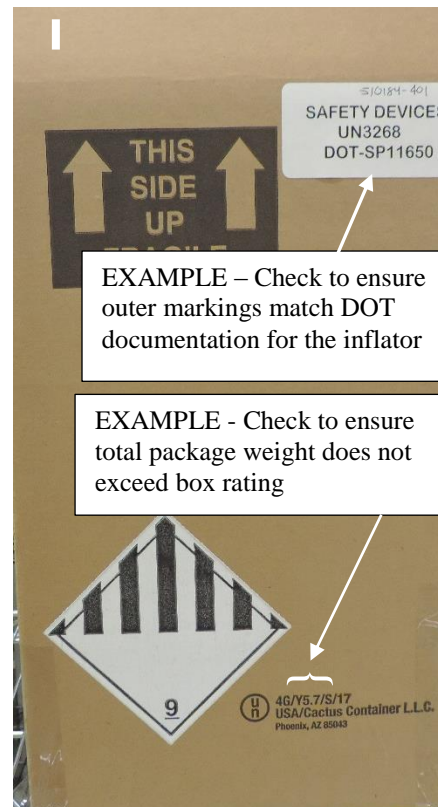
